Responses to questions will be provided by **4:00 PM Alaska Time, Tuesday, October 28, 2025** via Addendum. Bidders shall acknowledge receipt of all Addenda within their Bid.

Bidders shall specify in their response to this RFB in writing whether exceptions are taken to any of the terms and conditions of the attached Sample Construction Contract. Exceptions taken later may result in rejection of the Bid.

Please base your Bids on the following conditions:

- Contractor shall begin work within seven (7) calendar days of Notice-to-Proceed.
- Bids must be complete and include entries for all Bid Units listed.
- Contractor shall provide As-built surveys, one at excavation depth and one at final grade.
- A Bid Bond is required - A Bid Bond in the amount of 10% of the Bid shall be provided with the Bid Documents. A certified check made payable to “Chugach Electric Association, Inc.” may be substituted for the Bid Bond. Written releases of liens are required.
- Late Bids will not be accepted.
- Bids will not be opened publicly.

Bid Units shall reflect all work noted on the Bid and Contract Documents, even if not assigned a separate Bid Unit description.

Chugach reserves the right, in its sole and complete discretion, to define and/or waive irregularities, to accept or reject any or all Bids, in whole or part, and to reissue, withdraw or cancel the Project in its entirety for any reason, without incurring any liability of any type or nature to any Bidder or Contractor, including but not limited to any costs associated with Bid preparation and submittal.
